# important Guide-lines for the Revaluation

1. a) Re-evaluation is a CONCESSION granted to candidates and not as a matter of right.  
b) If candidates feels that his/her answer books has/have not been fairly evaluated, he/she may apply for a Re- evaluation provided a candidates seeking re- evaluation in a paper has secured at least 20% marks In the Subject/s concerned in the examination .A candidate have deposit Rs,280/- per script of revaluation.  
c) Re-evaluation of answer script /shall be permissible to the secondary School examination in Theory paper only.
2. d) No re-evaluation shall be permitted In the Practical examination.  
Application for re-evaluation should submitted to the joint Secretary (secrecy) J & K State Board of School Education on the prescribed application form duly attested by the Head of the Institution & shall reach the Board office within 15 days from the date of declaration of the result of particular examination I.e., The date printed on the Chairman provide such an application is received within 10 days of the last prescribed date.
3. Board of School education shall not be responsible for any variation in attested signature of the candidate on the application form of candidate.
4. Fee Re-evaluation Is not refundable.
5. a) The answer scripts In various paper shall be sent to two outside (non local) examiners In each paper re-evaluation. The result shall be determined on the basis of average to be drawn out of the three awards (received from the original examiner and two re -evaluators) which shall be declared subsequently under rules provided in their regulations. The grace marks awarded, if any or act regular examination, shall not be awarded in re-evaluation.  
b) While sending the answer scripts to a particular examiner for re-evaluation ten answer sheets or value points to students other than those who have applied for the same will be sent to the examiner concerned in order to facilitate the examiner to judge the standard of evaluation In the Board. In case accompany the answer script in question.
6. The candidate seeking re-evaluation is requested to submit an affidavit (declaration) duly sworn in before 1st Class Magistrate public Notary or an Oath Commissioner to the effect that the result re-evaluation shall be final and binding upon him/her.
